

Operation Guidelines for Company:

Login to **<http://dusgog.aau.in>** web address after login open the **Guj State Varietal Enrollment Portal** which further divided in **two parts**.

Part A: Basic information of companies like company name, license number, private limited, limited, research farm details, DSIR number, name of responsible person etc. need to be done online only once.

Part B: Upload of Marker Character (DUS) of Private research Varieties on Character Portal. Acknowledgement /Registration is to be done as per the PPVFRA. Also have to upload two years Yield production and pest disease data of trial conducted by companies itself/SAUs/ICAR.

Registration of Hybrid cotton and Hybrid paddy crop varieties was earlier done on based of the results of SAUs coded field trials. That system has been continued in the new system. (As per old system) Means registration should done on the bases of SAUs coded trial data.

According to the new system of Acknowledgement /Registration of varieties of Hybrid. Maize, Hybrid Bajra and Hybrid Castor crop the company will have to upload DUS character of the varieties along with the Yield production and pest disease data of trial conducted by companies itself and have to present such crop variety to the technical committee and based on that, Acknowledgement /Registration will be given.

For other crops up to two varieties/crops have been applied by the company for acknowledgment will be given based on verification of the details uploaded by the company. And for more than two varieties of any crop out of total applied varieties for Acknowledgement only 10 % will have to Present By Company to the Technical Committee.

The company having valid DSIR Certificate. Such a company will get exemption from presentation. But have to follow new online acknowledgment procedure has to be adopted. (Prescribed Online Application, Fees, etc. But Hy. Bajra, Hy. Castor and Hy. Maize crop varieties must have to Present By Company to the Technical Committee).

The company have to compare their own research varieties over last released variety of SAUs as check variety in Yield production and pest disease data of trial conducted by companies itself. If the seeds of such check varieties are not available, the local popular notified variety should be kept as a check and the details have to be submitted.

When a variety comes acknowledgment for special characters (diseases and pests), the details of Susceptible and Resistant varieties of that crop should have to be compare as check.

For identification support of DUS character upload Photo of plant, field view (farm) and Economic Important Part /Marker Trait.

The Varieties Which are commercially released in Bt cotton crop by Govt of India will be exempted from SAUs trial. But have to follow new online acknowledgment procedure has to be adopted. (Prescribed Online Application, Fees, etc...).

For Acknowledgement of non-notified varieties in Hy. cotton and Hy paddy crops, have to submit data from SAUs coded trials through Directorate of Agriculture or direct trials or through ICAR will be taken into consideration.

For Scrutinized varieties of Hy. Cotton and Hy. Paddy, other online acknowledgment procedures will have to be adopted. (Prescribed Online Application, Fees, etc...).

The companies selling the notified varieties have to gives the details of the notified varieties only. No need to enrolled.

Acknowledgment fees structure:

For all hybrid varieties	: 5000 Rs/-
For all varieties except hybrids	: 1000 Rs/-
Fee for each change in Part "A"	: 1000 Rs/-

Validity of Acknowledgment:

The tenure of first acknowledgment will be 5 years, thereafter the tenure of renewal will be 5 years.

No change can be made in the previously given DUS character while making acknowledgment in the new system under the same name of the varieties previously registered at department.

Varieties whose registration period is expiring as per old system should get acknowledgment within one month of completion of old registration period.

Among the seed varieties sole in the state, all varieties except those whose registration is ongoing under the old system, rest have to apply for the registration as per the new system by 30/04/2024.
